Clifton Hill Primary School is looking forward to another great year of teaching and learning and would like to advise you of Clifton Hill Primary School's voluntary financial contributions for 2023.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students.

Whilst the State Government supplies most of the school's funding, it is not sufficient to meet the costs of our extensive programs and offerings, some of which are listed below. Schools are dependent on locally raised funds to supplement the State Government's funding for our curriculum programs, services and resources. Locally raised funds in the form of voluntary parent contributions are therefore essential for the operation of our school's extended teaching and learning programs, specialist staff and the purchase of additional equipment.

Within our school the support of locally raised funds, particularly voluntary contributions, has allowed us to:

- offer a wide range of subjects and special curriculum experiences such as two LOTE programs and a specialist STEM program
- deliver our own unique school productions as evidenced recently by Ngulu-Nganjin, our 2022 grade 4-6 production
- enhance digital learning opportunities
- operate a literacy intervention program in years P-2
- offer extension programs such as Tournament of Minds, Maths Olympiad and Maths extension teaching
- extensively resource our school library
- employ a school nurse 5 days per week
- employ a school psychologist 1 day per week

We would like to thank you for your ongoing support, whether that's through financial contributions, fundraising, or volunteering your time. This has made an enormous difference to our school and the programs we can offer.

All voluntary contributions are allocated to student programs, specialist staff and facilities and everyone benefits from the contributions. The collective effect is very powerful when everyone contributes.



Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy and any other relevant information.

Notes

- ¹ In the interest of student health and well-being the School employs a Registered Nurse who is based in the sick bay from 10am to 3:30pm, Monday to Friday. Whilst this contribution is voluntary, the payment of the Nurse Contribution by parents and carers enables the school to employ a registered nurse. The presence of a school nurse at a primary school is not mandatory but the benefits are available for all students.
- ² This fund is to provide support to any families at our school demonstrating financial hardship. Your contribution helps to ensure that all our students have the option of attending school camps and excursions and have the items they need for school.
- ³ This contribution allows the school to purchase replacement HEPA filters for air purifiers and first aid materials and equipment for the school.
- ⁴ This contribution allows the school to employ personnel or buy materials to maintain the school grounds to a high standard. For example; purchasing tan bark in playground areas, repairing shade sails, replacing sand, painting poles, purchasing plants etc.
- ⁵ This contribution is tax deductible. Clifton Hill Primary School has a strong history of families contributing to our two tax-deductible funds; Building and Library. These contributions have enabled us to provide a high level of student learning and teaching opportunities. Recent examples of how these funds have helped Clifton Hill Primary School become the school it is today are: refurbishment of toilets, replacement of windows, painting of classrooms, carpeting of classrooms, replacement of classroom air conditioners and upgrade of MPR audio system. To continue to provide students with such facilities/resources, we suggest that all families, who are in a position to do so, **donate \$300 to either of these funds**. In the past family donations have ranged up to \$10000.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
